This MaineHousing Notice is being issued to provide clarification regarding the required submission of homeowners insurance denial letter (if they mark Yes they have insurance) for HARP projects.

1. Revised HARP Guidance and Procedures (04/03/2023)

Added - Section A2.C.3: Emergency Repairs

(3) Funds cannot be used to install home repair measures that is or can be paid by the property's Homeowner Insurance. Client must submit copy of the insurance documentation (denial letter).

Clarification

- Copy of Insurance denial letter is required for all Emergency & WSD projects. It is not required for Accessibility or Weatherization Readiness projects.
